## **Receive visitors/public comment:**

Donna Paup commented on the council's decision regarding no expiration date on building permits and shared a photo of a garage foundation from E First Street that was started several years ago and never finished. It now has trees and other vegetation growing up around it.

# **REPORTS:**

**Ambulance Report**: Coppess reported 21 calls for the month with 1 call to Lowden, 3 calls to Clarence and 2 calls to Stanwood. Yaneth Pena passed the EMT class and will be taking her practical test and the National written test.

**Fire Report:** Coppess reported 28 calls for the month with 13 being medical assists, 6 prescribed CRP burns; 7 grass fires, 1 weather, and 1 public assist UPRR.

**Police report:** Tim Horihan gave his summary of activity from 4/9/18 to 5/14/18 which included 49 business checks; 8 agency assists; 2 medical assist; 21 citizen assist; 2 motorist assist; 8 General Public Safety; 2 theft/fraud; 2 warrants; 1 assault/domestic case; 3 harassment; 7 suspicious activity; 5 animal cases; 7 juvenile cases; 1 welfare check; 3 civil cases; 3 nuisance/noise;1 mental health; 1 community event; 2 training; 15 parking violations; 38 traffic stops; 45 warnings; and 10 citations. Police was informed of a motorcycle parking on the skate park ramp and requested to take an inventory of the junk vehicles around town and serve notices for nuisance abatement.

**Public Works Report:** Lange reported that the new mower arrived, the water tower was cleaned and inspected and they are advising that the inside should be painted and a cable installed to climb it; sewer plugged on Kohlhase with a lot of sand pulled out, and council informed that the jetter is at Tipton being repaired. Council inquired about the catch basins being cleaned and mowing at the cemetery.

**Administration Report**: Coppess advised council of a receipt of a donation from the Monsanto Fund of behalf of Cedar County farmer, Dennis and Linda Coppess. The Mechanicville Sport Complex was selected to receive the \$2,500 through Grow Communities. The purpose of the Grow Communities program is to partner with farmers to make a positive impact in farm communities across the country by supporting local nonprofit organizations. Since the program began in 2010, more than \$29 million has been directed to organizations across rural America.

The Iowa Department of Agriculture and Land Stewardship issued the Commercial Pesticide Applicator License to the City of Mechanicsville for Dirk Wieneke.

The P&Z meeting that was scheduled for May 16 has been postponed until after the Cedar County Comprehensive Plan is made available and due to lack of quorum being available for that day.

**Sr. Citizen's painting donation:** The senior citizens asked for permission to hire a painter to paint the blue section of the building and the west side. The letter received states that Rick Crittenden is certified, bonded and insured. Dee Taylor motioned, Rob Davis seconded to accept the donation from the seniors. Ayes all. Motion carried.

**Letter for EMT class and volunteers:** Council reviewed a draft of a letter to be sent to all box holders looking to recruit additional EMTs for an upcoming class in August. Dee Taylor motioned, Eric Nehring seconded to approve the mass mailing to be completed.

**Fire personnel living /working in district:** Pam Cavey motioned, Rob Davis seconded to withdraw the approval authorizing the person to participate as a FF on Mechanicsville's roster until written approval was received from the City of Stanwood. Ayes all. Motion carried.

**Request for "Curb Cut" No parking permit for 501 S Cedar Street-driveway access from S. Elm Street; Chapter 69 Parking Regulations:** Coberly Investments LLC requested a 45 foot area in front of overhead doors that they will be installing and a 90 foot area for the Main driveway entrance. In addition AgVantage requested 2-40 foot driveway entrances on the west side of the road to be no parking areas for access to their property. The semi-trailer that is currently parked in the right of way will be moved on to private property. Dee Taylor motioned, Eric Nehring seconded to approve the no parking areas for driveway entrances on South Elm Street. Ayes all. Motion carried. Some discussion on possible required signage.

**Tile in alley behind city hall to East Second Street catch basin**: Storm sewer collapsed, council requested additional bids to be able to compare it to the one received. The pipe will be \$400 in addition to the labor bid.

**2018 Small City Workshop** Strategically Investing in Your Community: Information was shared with Mayor and council on the upcoming meetings being sponsored by the Iowa League of Cities.

**Sample Social Media Policy:** Coppess shared a sample of a social media policy that she received from attending IMFOA in Des Moines. It was for informational purposes only with no action being taken at this time.

Accept low bid on Rock Salt from State of lowa: Pam Cavey motioned, Dee Taylor seconded to approve the low bid of \$78.17 a ton. Ayes all. Motion carried.

**Proposed gutter work at Library:** Andrew Oberbreckling motioned, Dee Taylor seconded to approve the bid from Conrad Construction for working on the gutter at the library in the amount of \$985. Ayes all. Motion carried.

**Correspondence:** Unsigned document in drop box along with a copy of the Clarence Cardinal. Council discussed and was informed that the "City" doesn't have anything to do with the activities mentioned in the newsletter. Most of the work is being done by the Clarence Community Foundation and the Clarence Economic Development group and several volunteers. It is city policy to take no action on unsigned letters.

A copy of the letter of support for the Cedar County Great Places designation application was also shared.

Mayor Comments: Mayor requested that a topic of discussion for the next meeting be removal of tree stumps in the right of way.
