# Minutes City of Mechanicsville REGULAR COUNCIL MEETING December 10, 2018

Receive visitors/public comment: Cody Coberly informed council that water is coming into their building where they recently installed an overhead door and stated that the city needs to put a swale into the street and cut the concrete at the intersection of Cedar Street so that the water can get out to the storm sewer at Cedar Street. Council indicated that the water is coming from the railroad and flows from west to east in that area. The city didn't think lowering the grade of the street was the solution as it would make the problem worse and the undeveloped street would become impassible. The city didn't cut the hole in the building to cause the water to come into it. Perhaps property owner could install a field tile and connect into the nearby storm sewer. The City has not made any changes to that area for many years and this has never been a problem in the past. A couple council members will investigate it more.

Donna Paup stated that she recently attended the Board of Adjustment meeting and stated that she feels there is a need for training.

#### **REPORTS:**

Engineer report/update(V&K)- Emily Linebaugh presented the council with an update with where they were at on the facility plan process which currently they are in the Develop Treatment Alternatives step. Also touched base on direction to take with the Ecolotree pilot which council indicated to not spend a lot of time with the new technology, but do some to check if it could work as an option in order to save on the overall costs of the project. The issue with the new technology is that there is no data for the January/February/March months and a lot of proof has to happen and there are risks involved and piloting takes more time. Also indicated that the DNR has moved to a system of giving communities a compliance date and then asking for progress reports.

Ambulance Report: Koch reported 11 ambulance calls for the month and a summary of 208 calls for the year with 130 Mechanicsville, 26 Clarence, 18 Lowden, 18 Stanwood, 9 Tipton, 3 Rochester, 2 Lisbon, and 2 Oxford Junction. St. Luke's being the hospital transported to most with the University next. Mondays and Thursdays were the busiest days with Sunday the least. The incentive pay was approved with a motion by Pam Cavey and a second by Andrew Oberbreckling. Ayes all. Motion carried.

**Fire Report:** Koch reported 5 calls for the month and 160 for the year which included EMS assists. Sale of Air Compressor from fire: one sealed bid was received and opened in the amount of \$35 from Dan Baker. Pam Cavey motioned, Eric Nehring seconded to accept the bid and approve the sale. Ayes all. Motion carried.

A request to repair upholstery in 3 trucks was approved at a cost not to exceed \$300 with a motioned by Pam Cavey and a second by Dee Taylor. Ayes all. Motion carried.

**Police report:** Tim Horihan gave his summary of activity from 11/12/18 to 12/10/18 which included 32 business checks; 8 agency assists;1 medical; 13 citizen assist;3 motorist assist; 1 General Public Safety; 1 burglary; 0 alarm; 2 vandalism;1 assault; 0

harassment; 5 suspicious activity; 5 animal cases; 0 juvenile case; 1 MVA; 1 welfare check; 0 civil cases; 1 nuisance/noise; 19 parking violations; 41 traffic stops; 48 warnings; and 5 citations. Tim reported the YTD activity and went over his proposed budget. No action was taken on the request to approve ordering a patrol car with the up fitting and graphics at a total cost of \$65,000. The delivery time is approximately 150 days out and prefers to take delivery by July 1. Estimated the old car trade in value at \$2,000 with 76,000 miles on it, but only 2000 miles on the new transmission. Also suggested keeping as a back up

Public Works Report: Lange absent. Dirk Wieneke nothing to report.

**Administration Report:** Coppess shared information on new requirement of all businesses to report W-2 filings electronically to the State of Iowa. Scheduled to do a test with payroll Software Company later this week.

### Old business discussion and possible action on:

Ambulance Affiliation Agreement: Dee Taylor motioned, Andrew Oberbreckling seconded to approve the affiliation with Stanwood. Affiliation allows for the sharing of the 24/7 coverage of the schedule. Ayes all. Motion carried.

**Minor curfew ordinance:** Dee Taylor motioned, Pam Cavey seconded to change the time from 11 p.m. to 12 am. Ayes: Cavey, Taylor, Nehring and Oberbreckling. Nays: Rob Davis. Motion carried. The motion was made to approve the first reading of the ordinance with the time change and the change in the age from 17 to 18 years of age by Pam Cavey. Motion was seconded by Dee Taylor. Ayes: Cavey, Taylor, Nehring, and Oberbreckling. Nays: Davis. First reading approved.

Third reading on Ordinance 296 establishing procedure for Residential Handicapped parking space & application form: Motion by Pam Cavey and second by Andrew Oberbreckling to approve the third reading and adopt the ordinance. Roll call vote: Ayes Cavey, Davis, Nehring, Oberbreckling and Taylor. Motion carried. Ordinance adopted.

Ordinance permitting Golf Carts & UTVs to be driven on city streets: Dee Taylor motioned, Eric Nehring seconded to approve the first reading of the ordinance. Ayes all. Motion carried.

**Ordinance on No Parking zones:** Item 4 was changed to read both sides of South Elm Street and item 7 deleting the no parking on south side of South Street between Cherry and Monroe. Motion by Pam Cavey, seconded by Andrew Oberbreckling to approve the first reading. Ayes all. Motion carried.

## New business discussion and possible action on:

Ordinance 297 amending provisions pertaining to alcoholic beverage control was read and the first reading was approved with a motion by Pam Cavey, seconded by Dee Taylor. Ayes all. Motion carried.

Dee Taylor motioned, Eric Nehring seconded to waive the 2<sup>nd</sup> and 3<sup>rd</sup> readings. Ayes all. Motion carried. Dee Taylor motioned, Rob Davis seconded to adopt the ordinance amending provisions pertaining to alcoholic beverage control. Roll call vote: Ayes: Cavey, Davis, Nehring, Taylor, and Oberbreckling. Nays: None. Ordinance adopted.

Ordinance 298 amending provisions pertaining to cigarette and tobacco permits was read and the first reading was approved with a motion by Pam Cavey, seconded by Dee Taylor. Ayes all. Motion carried.

Dee Taylor motioned, Rob Davis seconded to adopt the ordinance amending provisions pertaining to traffic regulations (texting). Roll call vote: Ayes: Cavey, Davis, Nehring, Taylor, and Oberbreckling. Nays: None. Ordinance adopted.

**Home Rule Proclamation:** Dee Taylor motioned, Eric Nehring seconded to authorize the Mayor to sign the Home Rule Proclamation recognizing the 50<sup>th</sup> anniversary of when the citizens of Iowa approved the adoption of Home Rule in the Constitution of Iowa on November 5, 1968. Ayes all. Motion carried.

**Correspondence**: A copy of a sample ordinance on outdoor wood burners was received and distributed with no action to be taken at this time.
